Alessandro Botto is a partner of the Administrative Law department. Before joining Legance he was a member of the Third Section of the Consiglio di Stato. He has been elected Presidente Commissione Normativa (President of the Regulations Board) of IGI - Italian Institute of Major Infrastructures in 2015. Alessandro is currently a member of the scientific committee of Gestore dei Servizi Energetici (company in charge of the promotion and development of renewable sources and energy efficiency in Italy).




